### Contractual Obligations:

I agree on photo taking of my brows only and using the photos for advertising and training purposes.

### The following risks are specifically explained to the client:

During the procedure despite the staff expertise and all the precautionary measures, injury is possible. Despite the application of the most advanced and the top quality pigments, allergic reaction is possible but rare. The client is informed about this and he/she assumes liability. (initial)\_\_\_\_\_

During and after the procedure temporary swelling, redness and/or itching may occur. (initial)\_\_\_\_\_

Depending on the skin structure after the first treatment small scabs with a loss of drawn hairs may occur and color intensity may change. (initial)\_\_\_\_\_

In the first seven days eyebrows are up to 40% darker and 10-15% thicker. Color reflection depends on the natural skin pigment. (initial)\_\_\_\_\_

The pigment is absorbed differently due to differences in the skin quality, thus there is no warranty for the treatment success. (initial)\_\_\_\_\_

The shape is determined according to the face proportions. (initial)\_\_\_\_\_

Depending on the skin structure it should be noted that change in the color intensity is possible and that one or more additional treatments will be required. (initial) \_\_\_\_\_

The minimum or maximum duration of micro-blading or permanent makeup procedures cannot be determined with certainty, nor can the warranty be given on performed treatment. (initial)\_\_\_\_\_

Any touch ups fees may apply for future appointments if touch ups are desired.

If most of the color has faded, then this will not be considered a touch up and all fees for a new service may apply. Touch ups are usually performed after 6-8 weeks. For oily skin it may be necessary to perform more corrections. (initial)\_\_\_\_\_

Permanent make-up always leads to skin injury. Therefore, it is important to carefully and gently nurture your skin after the treatment to allow healing without complications.

Inadequate care during healing phase of the skin can lead to poor results and Very Aesthetic Skin+ Brows cannot be liable for improper aftercare. (initial) \_\_\_\_\_

**Permanent Makeup is an art and not science. Client results will vary and using a makeup pencil or brow powder may still be needed.**

**In the next 7 days the client is required to pay attention to the following:**

Keep your eyebrows dry and clean for the next 7 days. (initial)\_\_\_\_\_

Avoid contact with water. The thick crust will appear, and all the pigment will fade. (initial) \_\_\_\_\_

Do not touch the scab in any other case except while cleaning. (initial)\_\_\_\_\_

For post-treatment care only use recommended liquids to clean the brows (initial)\_\_\_\_\_

If skin is oily or sweaty make sure you clean the skin when necessary (initial) \_\_\_\_\_

Please do not use any other creams except the ones recommended to you in order to prevent possible infections or allergic reactions. (initial)\_\_\_\_\_

## VERY AESTHETIC SKIN + BROWS

### ALL PERMANENT MAKE-UP PROCEDURES ARE MULTI-SESSION PROCESSES.

An initial application is incomplete until after a touch-up appointment, which should be scheduled approximately 6 weeks after your initial appointment. There may be an additional charge for the touch-up appointment after your initial application if it is not included in your service price. First 'follow up' is recommended to be performed within 3 months of the initial application. Two or three applications may be required to achieve the desired results. It is not uncommon to lose up to 70% of the color on the first application. WHILE YOUR SKIN HEALS, BE PREPARED FOR THE COLOR INTENSITY OF YOUR PROCEDURE TO BE SIGNIFICANTLY LARGER, SHARPER, BRIGHTER, OR DARKER than what is expected for the final outcome. This is a normal and expected result of the application and healing process. The healing process will take a number of days to complete, depending on how quickly the outer layer of your skin exfoliates and new skin regrows to take its place.

## BEFORE & AFTER CARE INSTRUCTIONS

### BEFORE THE TREATMENT:

- Do not take Aspirin, Niacin, Vitamin E or Ibuprofen 24 hours before the procedure
- Do not drink coffee, alcohol or energizing drinks on the day of procedure
- Tint brows at least 1 week prior to the permanent makeup procedure
- Do not tan or sun bathe 30 days before procedure
- Do not wax 2-3 days before procedure
- Do not have any chemical peels, dermabrasions, mesotherapy, or any other intense treatments which will cause faster skin cell rejuvenating and cause skin irritation 3-4 weeks before procedure.
- Wash your hair before the procedure

### AFTER THE TREATMENT:

- Avoid contact with water or any other liquids than what was recommended for 7 days after the treatment. Even a small drop which seems unimportant may expand the wound and scabbing will appear
- Aftercare will vary by skin type. Please follow your care instructions verbatim. This will help remove any excess lymph, blood and pigment that may appear after the procedure.
- In case of dryness, but not earlier than the 3rd day, apply a very small amount of the ointment provided.
- Make sure your eyebrows are not greasy, but moistened a little so you won't see any residue of the oil.
- After 7 days you may use a gentle soap or non-greasy facial cleanser to keep the eyebrows clean.
- Do not use other ointments, cream with vitamins or antibiotics on eyebrows during the healing process.
- No sunbathing or tanning for 4 weeks. No chemical peels, mesotherapy, dermabrasion, botox and any other strong treatments for 3-4 weeks.
